Individualized Dental Care - Thinking Outside the Box

This is a **FREE two-day in-person** continuing education course offered to dental professionals to update their knowledge in dental care for people with unique physical, intellectual, or medical needs. Matthew R. Cooke, DDS, **MD**, **MPH**, will present the most current clinical information and interactive case-based discussions regarding effective and safe levels of dental care for all individuals regardless of their specific needs. Topics to be addressed include treatment planning to address risk vs. benefit; behavior guidance techniques; disabilities, syndromes, and conditions with orofacial manifestations; ethics, advocacy, and trends in dentistry; and integration of more patients into your practice. Kami A. Piscitelli, BSDH, RDH, VA Department of Health Disabilities and Chronic Conditions Oral Health Coordinator, will also provide a presentation with tips and tricks for making dental visits easier for some patients, and hygiene adaptations for people with home care challenges.

The course is tailored to an audience of dentists, dental hygienists, dental assistants, and senior dental/hygiene students. No prior skill level or knowledge other than previous basic dental knowledge is required. Teaching methods include lecture and audience engagement. This course will not be offered online or recorded.

- Discuss the need for three components of treatment planning: Medical, Dental/Surgical, Behavioral.
- Identify at least one reason for determining risk-versus-benefit while treatment planning.

- Recognize the need for the entire dental team's involvement when treating patients.
- Point out a few clinical tips or hygiene tool modifications for patients with unique challenges.
